Information we collect

Information you give us: Three Moon receives and collects information you enter on our website or give us in any other way. Certain information you can choose not to provide, but we use the information that you do provide to respond to your requests, improve our services, and communicate with you.

Information collected automatically: Three Moon automatically receives certain types of information whenever you interact with us, including but not limited to certain types of information when your Web browser accesses threemoonpublishing.com. At this time Three Moon does not store this information, but we reserve the right to change this practice and this Privacy Policy to do so when we feel that the information will enhance your personalized experience at threemoonpublishing.com.

Information collected from other sources: Three Moon may receive information about you from other sources and add it to our information. Information provided to others
